

The notification procedure for hazardous mixtures

Since 1 January 2021, only the notifications of hazardous mixtures for industrial uses shall be submitted via the online notification system OSZIR. Notifications by email or post will not be accepted. **From 29 June 2021, there is no obligation to notify hazardous substances anymore, according to the Act.**

To gain access to the OSZIR system, **registration is required on the webpage: www.antsz.hu** by clicking on ‘OSZIR’ and choosing the option “KB31: Chemical Safety Notification” on registration, allowing you to submit hazardous mixture notifications to the Hungarian poison centre. The system can be used with your user name and initial password which you receive within a few days of the registration.

It is important to note that, **for the registration, the company name, address and the tax number of the company on whose behalf you intend to submit notifications shall be provided.** It is not a requirement for the registered/notifier company to have legal personality in Hungary. Please fill in the registration form according to our attached guide in which you will also find screenshots for your convenience.

It is to be highlighted that in the OSZIR system the term “*partner*” refers to the notifying company (itself) whose username and password you use to login into the system.

Please note that **notifications can only be initiated/submitted** in the OSZIR system **after the partner/company details have already been given in the submenu “Partner adatok karbantartása”** (Maintenance of partner details) of the menu “*Karbantartás*” (Maintenance). As a first step, please enter and save the company details (addresses, responsible person and contact information) according to the attached guide. We would like to emphasise that it is mandatory to provide a telephone number, e-mail and fax number; you will not be able to submit notifications without these.

In accordance with §6 of the Act, companies, which manufacture/produce, import or distribute any kind of hazardous mixture(s) in Hungary, for industrial use only, have the obligation to notify their hazardous chemicals to the National Public Health Center (NPHC) at the beginning of their operation, **unless the same mixture has been notified previously.**

This means that a hazardous mixture identified with the same trade name does not need to be notified to the OSZIR system more than once. In case you try to notify a hazardous mixture which has already been notified in our database, the procedure will be terminated and the notification will be deleted from the OSZIR system.

In order to avoid unnecessarily initiated notifications, which have to be terminated, it is advisable (but not mandatory) to require information (via ettsz@nnk.gov.hu e-mail address) before submitting a notification for a "new" product. Requesting this information is free of charge.

As in Hungary the online database of the hazardous mixtures is based on the trade name of the products, if you request such information from the ETTSZ, please provide the exact trade name of the hazardous mixture as it appears in section 1.1 of the SDS (safety data sheet).

According to the Act, those mixtures which can be classified in any hazard classes or categories in line with the classification criteria of Regulation No 1272/2008/EC (CLP) are considered to be hazardous. **Only hazardous mixtures have to be notified.** (The indication of any EUH-phrases, in itself, does not imply a hazardous classification.)

In line with §2 (3) of the Act, **the above applies to all hazardous mixtures except for the following:**

- a) Medicinal products, veterinary medicinal products, products and substances considered as medical devices,
- b) Psychotropic substances, narcotics, drug precursors,
- c) Cosmetic products,
- d) Substances and mixtures classified as waste,
- e) Radioactive substances and mixtures,
- f) Food stuffs as defined in Regulation (EC) No 178/2002
- g) Feeding stuffs as defined in Regulation (EC) No 178/2002
- h) Pesticides,
- i) Other hazardous mixtures for which notification, authorization or other administrative procedures are specified by other legislation provided that the requirements of those legislations are in line with this Act.

The telephone number of the Hungarian official advisory body is +36-80-20-11-99. This is a toll free, 24 hours' service maintained by the “*Egészségügyi Toxikológiai Tájékoztató Szolgálat*” (ETTSZ) (“*Health Toxicological Information Service*” (HTIS) in English). **This telephone number has to be included in section 1.4 of every Hungarian safety data sheet** and there is no need to ask any permission for its inclusion. In addition to the above mentioned information the supplier has the opportunity to indicate a reference to its own emergency service(s) in this sub-section, as well.

According to §2 (1) of *Decree No. 1/2009. (I.30) of the Minister of Health on the fees payable for the administrative procedures and services of the National Public Health and Medical Officer Service* **the notification of hazardous mixture is subject to an administration and servicing fee.** The current fee of notification is *9,200 HUF per each mixture* (See V.3. of Annex 1) which **must be present** in our account after deduction of bank charges.

The fee shall be paid to NPHC upon initiating the notification. Please be informed that we can accept transactions in Hungarian Forint (HUF) only. You can use the “*payment order for foreign currency*” in order to initiate the transaction.

Please note that it is also possible to pay the administration and servicing fee by **debit/credit card**, not only by bank transfer. Payment by credit card is going to entail no additional cost (bank charges and deductions). In this case you have to choose „*Bankkártyás fizetési mód*” (Payment by credit card) option instead of „*Egyéb fizetési mód*” (Other payment) in our online notification system (OSZIR) when you indicate the new notification.

The administration and servicing fee (hereinafter referred as fee) **is payable for conducting the procedure in cases of products for industrial uses only (regardless of the result of the procedure), so there will be no refund of the fee, even if the procedure ends with termination and the notification is deleted, for any reason. If you submit a product with professional/consumer use, the NPHC will terminate the procedure and delete the notification. In these cases, NPHC must refund the fee to the payer.**

The notification of a hazardous mixture is considered complete, if the **Hungarian Safety Data Sheet (SDS)** has been attached, the **administrative fee** has been paid and the **certificate** has also been attached.

It is important to know that the name of the product in the notification has to be identical that given in the attached documents.

According to paragraph (1) of §6 of the *Act*, the notifier **companies have the obligation to update their previously accepted notifications, if the SDS of the notified product changes**. The update notification is free of charge.

It is important to know that **in Hungary hazardous products are identified by their trade name**. If the trade name of the product notified already in the OSZIR system changes, due to the fact that the trade names of the products have been changed for any reason, new notifications are needed. If you intend to notify a product for professional/consumer use, due to name change, you have to do so it in the PCN system.

Furthermore, **a representative in charge with the notification of hazardous mixtures intended to be placed on the Hungarian market, acting on behalf of a company, shall be able to demonstrate his/her proxy**, if it is not included in the provision register, according to paragraphs (1)-(2) of § 14 of Act No. CL of 2016 *on the General Administrative Order* (Ákr). The proxy shall be included in an authentic instrument or a private document of complete probative value or shall be recorded, and a scanned copy of that document shall be attached to the system. If the proxy does not indicate otherwise, it shall be considered a general one, covering all the declarations and actions relating to the proceedings. The proxy has to be sent to the following address: bejelentes@nkk.gov.hu.

In case of a non-complete request (see above: Hungarian SDS, certificate of payment of the administrative fee, if applicable attachment of a copy of the document about the proxy, etc.), the authority will order the notifier to amend his notification or make a declaration within a reasonable time given by the authority. Such an order can only be issued once.

If the applicant fails to comply with the request for amending the notification and/or making a declaration within the deadline set, the authority will terminate the procedure. If the notification submitted has been found incorrect, after the order of amendment, the procedure will also be terminated.

Once the submission is complete, the notification will be confirmed by changing its status into ‘registered’ (“Nyilvántartásba vett”). The notifications included in the system can be printed out but no separate certificate is needed to be issued to verify the registered status of the notifications. **In case of any deficiency, we will inform the notifier through an official decision which can be found attached in the online system, but we also send it by post.**

While, currently, **only hazardous mixtures with industrial uses are required to be submitted through the OSZIR-KBIR system**, submissions for hazardous mixtures for professional and/or consumer use are to be made via the **European Chemicals Agency’s (ECHA) designated Poison Centres Notification Portal** (hereafter: PCN). **Please also note that, according to Annex VIII to CLP, from 1 January 2025, all products will have to be submitted via the PCN portal.** Substances and non-hazardous mixtures can also be notified via the PCN portal, on a voluntary basis (free of charge).
